GENERAL RULES & ELIGIBILITY REQUIREMENTS

General Information:

1. Three (3) Scholarships are available for High School graduating seniors in the amount of \$1,500.00 each.
2. All applications will be reviewed by WSC Scholarship Committee and scholarships will be awarded at the sole discretion of the Committee. Decisions of the Committee are final. The Scholarship can only be received one time by any applicant. Acceptance of the Scholarship constitutes permission of the recipient for promotion of his or her name and/or likeness by the WSC. (BWSC Child Photo Parental release form must be completed and submitted with the application.)

Payment and Repayment Terms

Scholarships will be paid directly to the College, University or Approved Trade School to which the awarded applicants have enrolled. Prior to issuing payment, students must submit proof of enrollment and a billing statement and/or receipt from the registrar's office, including student ID #.

1. Payment Timing: The scholarship funds will be disbursed to the recipient/institution 30 days after the recipient's official enrollment in the educational institution.
2. Repayment Obligation: If the recipient withdraws from the educational institution or otherwise fails to meet the scholarship requirements, the scholarship may be revoked and/or award may be subject to repayment to Bolivar WSC.

Deadline:

All applications are to be received on or before **January 31st, 2026.**

Eligibility Requirements:

1. Parents or Legal Guardian of applicants must have an active, minimum of one-year, membership with BWSC at the time of application submittal.
2. Applicants must maintain a minimum of 2.0 GPA and demonstrate an acceptable standard of good character as evidenced by a letter of recommendation.
3. Applicants must be accepted as a full-time student by either a business, trade, or college institution.
